## Part B – Airport Charges for Handling and other services

### 1. General Conditions

#### 1.1 Debtor of fees

Debtor of the fees are at the time of use as joint debtor:

- The airline, which callsign or flight number is used.
- The airline as joint debtor, which callsign or flight number is used in case of code-sharing.
- The aircraft operator
- The natural or legal person, who is using the aircraft, without being the operator or owner (e.g., lessee or renter)
- The owner of the aircraft

#### 1.2 Payment conditions

All fees according to this charges regulation must be paid in Euro before the departure in cash, EC-Card, credit card (VISA or MASTER). Invoicing and payment are done immediately in these cases.

In particular cases the fees can be paid by invoice after an agreement with the Flughafen Braunschweig-Wolfsburg GmbH to open an account. The invoicing will be periodically.

Complaints can only be accepted within four (4) weeks after invoicing date.

#### 1.3 Value Added Tax (VAT)

All fees are fees according to § 10 paragraph 1 of the German VAT law (Umsatzsteuergesetz). Therefore, the debtor must pay VAT (19%) additionally.

#### 1.4 Validity

This regulation is valid from May 1<sup>st</sup>, 2024, and replaces the previous regulation of Braunschweig-Wolfsburg airport valid from April 1<sup>st</sup>, 2023).

Only the German version of the charges regulation document shall be legally binding. Translations into other languages are provided solely for information purposes.

## 2. Apron Handling

For handling of aircrafts, the operator or pilot has to pay fees to the airport according to this fee schedule.

### 2.1 Apron Service

Apron Services includes following services:

- Marshalling of aircraft
- Placement of Chocks (as requested by crew or airline)
- Securing of the aircraft by pylons
- Loading and offloading of the aircraft

The fees are calculated according to the MTOM of the aircraft. "Apron service" will be charged if the aircraft departs with passengers. If the aircraft departs without passengers or has just landed and departs another day, "Ferry-Apron service" will be charged.

## 2.2 Apron service related to an emergency landing

For Apron services, which are needed after an emergency landing, the fees are reduced:

>60.000 kg	533,66 Euro

If the fees for „Ferry-Apron service“ are less, the lower amount will be charged.

## 2.3 Marshalling / Follow-Me-Service

For Marshalling to the secure position of the aircraft, the following fees will be charged, independent on the size of the aircraft:

## 2.4 Other services on the apron

Other services, which are not covered by „Apron services“:

### 3. Passenger services (Check-In)

Die Passenger service includes the following services:

- Check-In
- Boarding
- Care of UMs and MAAS
- Post processing of flights (e.g., Sending of MVT, LDM, etc.)

The fees are calculated by the Seat capacity (SPK) of the aircraft.

For late night check in on the previous day an extra fee of 303,45 Euro will be charged.

For passenger services outside the regular operational hours an extra fee of 415,70 Euro will be charged.

### 4. Cabin cleaning

The fees for cabin cleaning are calculated by the seat capacity of the aircraft.

An early request is mandatory, due to service by external company.

At Braunschweig-Wolfsburg airport the following winter services are offered.
